**DECISION**

**"ON DEPOSIT IN THE REGISTER OF NON-PROFIT ORGANIZATIONS"**

In Tirana, today on 29.05.2026, I, **Miranda Nakaj**, judge at the First Instance Court of General Jurisdiction Tirana, having studied the request and the acts pertaining thereto:

- APPLICANT:** The "Albanian Ophthalmological" Association, approved by Decision No. 2795, dated 08.03.2010, by Tirana District Court, with registered office at Rr. "Gjon Kastrioti", Nd. 47, Laprake, Tirana.
- SUBJECT MATTER:** Deposit of Decision No. 2 of the Extraordinary Assembly of the "Albanian Ophthalmological" Association, pursuant to the agenda decision dated 25.09.2025.
- LEGAL BASIS:** Law No. 80/2021 "On the Registration of Non-Profit Organizations", Articles 4, 5, 6, 8, 9 et seq. of the established Statute of the Albanian Ophthalmological Association, based on Law No. 8788, dated 07.05.2001 "On Non-Profit Organizations" as amended, and No. 8789, dated 07.05.2001 "On Non-Profit Organizations", as amended.
